In accordance with the provisions of section 10 of the Request For Proposals and the provisions of the Procurement Policy of the LOC, the Bidder is informed of the aspects that must be corrected or clarified related to its offer, within a period of **3 BUSINESS DAYS**, either to clarify what was requested or to deliver the documents requested below.

The term is non-extendable and if it does not provide the require corrections and clarifications the Organization will interpret it as a declaration of non-interest by the Bidder and therefore its offer will be excluded from the contest, declaring it inadmissible

1. Legal and Formal Aspects:

- 1.1 The affidavit must be authenticated by a notary/attorney
- 1.2 The offer makes a list of events and clients, but the experience must be declared through a sworn statement authenticated by an attorney with the details of what is indicated in point 7.2.7 of the RFP
- 1.3 Provide letters according to the 7.2.11 RFP to be properly evaluated.
- 1.4 Documentation of the person who is leading the project must be certified by a public notary/attorney.

2. Technical Aspects

- 2.1 It is requested to clarify the reason why a technical solution and detailed description of each required service (web platform, access control, and customer service) was not included with the offer and provide us with this documentation. Otherwise, the offer will be rejected.
- 2.2 Indicate what mechanisms would be proposed to promote the event through the platform offered
- 2.3 Clarify if the unit cost per ticket includes bank commissions.
- 2.4 Clarify if the access control costs are based on the purchase of the devices.

Versión en Español

1. Aspectos Legales y Formales:

- 1.1 La declaración jurada debe ser autenticada por un notario.
- 1.2 La oferta hace un listado de eventos y clientes, pero la experiencia debe ser declarada mediante declaración jurada autenticada por abogado con los detalles de lo señalado en el punto 7.2.7 del Pliego
- 1.3 Proporcionar cartas de acuerdo a la RFP 7.2.11 para ser debidamente evaluadas.
- 1.4 La documentación de la persona que lidera el proyecto debe ser certificada por un notario/abogado público.

2. Aspectos Técnicos

- 2.1 Se solicita aclarar el motivo por el cual no se incluyó en la oferta una solución técnica y una descripción detallada de cada servicio requerido (plataforma web, control de acceso y atención al cliente) y proporcionarnos esta documentación. De lo contrario, la oferta será rechazada.
- 2.2. Indicar cuáles son los mecanismos propuestos para promover el evento mediante la plataforma ofrecida
- 2.3 Aclarar si el costo unitario por boleto incluye comisiones bancarias.
- 2.4 Aclarar si los costos de control de acceso se basan en la compra de los dispositivos.
